# SECRETARY'S REPORT

Respected President, Executive Committee members, the distinguished Ordinary/Life/Patron members and Staff of MESCO Education Society (MES) and MESCO, it is indeed an honour and pleasure to submit this report before you. An exciting year has gone by and an even more eventful year is ahead for MESCO Education Society (MES).

Accounts of MES were completed and audited by M/s. CNK & Associates LLP. You may refer audited Balance Sheet along with Income and Expenditure, Receipts and Payments accounts on page no 5, 6, & 7. During the period under report, the total income for the year was Rs. 2,33,58,907/- of which Rs. 2,27,82,679/- were spent on our institutions and on establishment expenses and Rs. 41,61,738/- on Capital expenses. The difference of total income and total expenses were (deficit) i.e. Rs. 60,30,452 was carried to the Balance Sheet.

With tremendous pride, I would like to state that our all three institutes (a) Crescent English High School (b) Vocational Training Centres and (c) Nursery Schools under MES are making the impact of their intervention amongst the students coming out of these institutions. This continues to be possible with the dedicated staff members of all our institutes. Your engagement has given many students the chance of building a bright future but the work is hardly close to over and our journey continues.

I would also like to thank my co-board members for their time and dedication towards the Organization. During 2013-14, we held 13 Executive Committee Meetings. There were 7 members on the Committee.

We have always believed that any organization's growth is basically linked with the growth of its people. Hence, we encourage diversity and a performance driven organizational culture in which people give their best and feel proud to be part of a successful and a caring organization.

As a caring organization, during this financial year 3 important policies, related to staff welfare were framed [1] for the immediate relief of Rs.20,000/- for any hospitalization of the staff members and their family members, a policy on Staff Welfare Fund was framed. The said fund was sustained by initial financial assistance of Rs.25,000/- from MES and contribution of subscription amount from the employees enrolled as Members [2] For the safety of lady staff members at Work place, as per The Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal ) Act 2013, an Internal Complaints Committee consisting of 5 members, was formed and [3] Policy on Allotment of Staff Quarters for the Teaching staff of Crescent English High School.

Maulana Azad Education Foundation (MAEF), New Delhi was registering NGOs as their partners; in this regard necessary documents along with their application form were submitted to MAEF. We were successfully able to register our organization under MAEF NGO partners, vide registration no. 13MAH003-MAEF. On Aug 2013, a delegation from Ministry of HRD Govt. of India, visited our Crescent English High School in respect of fund received from the Ministry of HRD under their Scheme of IDMI. Their queries were answered satisfactorily and all the necessary supporting documents were provided to them.

MESCO (the parent organization of MES) had organized 3 workshops on NGO Governance. All the trustees and senior staff members of the Society attended the same.

For the Administrative staff members, a Team Building Session was organized on 7th Dec. 2013 at J.J. Nursing Malad.

During the period, Mr. Akbar Moosa Dange and Mr. Niyaz Ahmed Nakhwa were inducted as Life Members and Mr. Aftab Ayub Shaikh was inducted as a Patron Member of the Society.

We have received Rs.2 lacs towards the Corpus for Vocational Training Centre from Mr. Mohammed Masud Bhaiji. Ms. Julia Eckert (Switzerland), Mr. Mukhtar Chougle (Saudi Arabia) Mr. Mubeenuddin (Singapore), Nini and Butch (Creative Against Poverty, UK), Mr. Adamji Jasdanwala, Bharati Shirish Mody Charitable Trust, Cathedral & John Canon School, Mr. Vijay Lahoti and Ms. Anupa Tanna Shah contributed for our Nursery Schools' activities. Under Corporate Social Responsibility (CSR) we received Rs. 1, 50,360/- from M/s. Worley Parsons Sea India Pvt. Ltd. and Rs. 22,500/- from Intas Pharmaceuticals. Bai Frency Darab Padar Charitable Trust donated Rs. 50,000/-, Mrs. Nasreen Hafizullah Baig donated Rs. 1,00,000/- towards School's Civil Construction work. Mr. Yusuf Nalwala and M/s. Detinners Pvt. Ltd. contributed towards the School and General donation. Mr. P. S.Saiyed has donated Rs.70, 000/- towards MESVTC activities. I hope I have not missed any name, and would apologise for any omission.

During this entire year, tremendous efforts were put in for the sanctioning of New Development Plans for the New School building. In respect of the amended plans (of the existing building) submitted to Thane Municipal Corporation (TMC), The Society had paid Rs.17,72,787/- towards 6 different heads, specified by TMC. On 18th March 2014, we have received Sanctioned Amended Plans Order for the existing School building. We are hoping to get the approved plans for the new school building very soon.

With inputs from the Executive Committee and staff members, a beautiful landscaping plan for the school campus was developed and have been partly implemented.

<u>Crescent English High School</u> is a Minority Institute hence it is not covered under The RTE Act. In spite of its Minority status, on the basis of our ideology that no child should be debarred from acquiring education and inspite of financial constrain; the management decided to provide freeship /scholarship to 25% students from Economically Weaker Section of the Society who had applied for Nursery Class admission.

To find out the Socio Economical status of students' families, a questionnaire (seeking information about Economical and Social conditions) for the parents of Crescent School was sent and data collected and analyzed.

We received Rs. 4 lacs as a grant from Maharashtra Government under their Schemes for Minority Educational Institutions. The said amount was spent on the specified purposes (mentioned in the application form) and the Utilization Certificate for the same was forwarded to the concerned Government Department.

Mr. Azeem Durrani (Headmaster) attended an orientation programme for 2 weeks at New Delhi organized by NUEPA, (National University of Educational Planning and Administration, New Delhi) in regard to Capacity Building for principals of minority institution all over India.

During the year, the total strength of the school was 998 students with a teaching staff of 38, non-teaching staff of 5 and auxiliary staff of 8.

Since last 4 years, the school has been consistently getting A-Grade Certificate from the Maharashtra Board of Secondary Schools, Pune. Our school received the Best School Trophy and Mr. Azeem Durrani received the Best Principal award from Mr. P.A. Inamdar Academy Pune, Mr. Vikas Sawant (ICT Staff) received 2nd prize and cash of Rs.5000/- for scoring 2nd highest in the ICT exam conducted by P.A. Inamdar Academy in Kausa, Mumbra. Ms. Oneza Siddique (Std.X student) received 3rd Prize for securing 3rd rank in Mumbra, Kausa in the ICT exam conducted by P.A. Inamdar and a cash of Rs.3000/-.

Our school received the runner up trophy for Throw Ball (boy's team under 14 years) from District Sports Organization, Thane. Mst. Arshad Saba and Mst. Gazanfar Khan received Cash Prize of Rs.5, 000/- each and a certificate at the National Muslim Talent Search Competitive Examination conducted by Human Welfare Foundation, New Delhi.

The school has been consistently achieving 100% results of SSC. The 9th Batch of SSC students (which appeared in March 2014) have made us proud by achieving cent percent result with highest score of 93% and class average of 73%.

A Chain of English Medium Nursery Schools: We all are convinced that if the vicious cycle of illiteracy and ignorance has to be broken, doorstep school at the pre-school level was needed to be set up. With this in mind, we started our institutional activity in the form of a nursery school long back in the earlier 1970s, last year (2013-14) we were managing a chain of 14 English Medium Nursery Schools in the slum areas of Mumbai and suburban. The children from the lower and middle lower income group and slum dwellers are the main beneficiaries. As we look back we estimate that more than 10,000 students must have received their first schooling in one of our Nursery school premises.

Vocational Training Centre Mumbra: During the period under report, we had an enrolment of 52 students for Electrician course, 32 for Air-conditioning and Refrigeration course, 40 for Professional Beautician Course, 50 for Dress making and Fashion Designing, 28 students for Information Technology and 41 students for Computer Hardware and Networking course. We are extremely happy with the performance and employment status of students of our Vocational Training Centre at Mumbra, running in collaboration with Fr. Agnel Technical College, Bandra. To review the performance of the Centre and to get feedback of passed out students, on 29th September 2013, Alumni Meet was held for students who had passed out during 2008-09, 2009-10, 2010-11 and 2011-12. In the said meeting data were collected from 214 students and on 11th January, 2014 an EX Students' Directory was completed of passed out students and published.

Due to space constraints, the present premises of VTC were not so suitable for conducting vocational courses; hence we were looking out for some suitable premises in Mumbra and Kausa. The concerned staff members had identified suitable premises of approximately; 2900 sq. ft. costing Rs.1.7 Crores. We are looking for donors who can donate funds for buying the premises.

<u>MES'VTC – DHARAVI:</u> During 2013-14, we were able to run 03 batches of Sewing Classes, where 68 students had enrolled, and likewise for the Beautician Course there were 38 students in 03 batches. This centre is also under the monitoring of Fr. Agnel Technical College, Bandra.

Overall MES had a very positive year. On behalf of the board I would like to extend my sincere thanks to our Bankers, Auditors, Contractors and collaborators, who were very co-operative throughout the year, and to volunteers who helped out in carrying out surveys.

Finally, as I end this report, I have to thank all my Committee members, staff members, Ordinary, Life and Patron Members, Well-wishers and Donors too numerous to name individually, but for whom we could not have achieved all this success in our endeavors. We thank the Almighty for accepting our services and guiding us all the way.

# **Crescent English High School**

In the year 1993, MESCO Education Society's Crescent English High School was established to inculcate value based education kindling the inherent talent of the students. The school is now one of the most reputed schools of the area. The academic year 2013-2014 began on 17th June, 2013 with a warm welcome to all our students. The total strength of the school was 998 students with a teaching staff of 38, non-teaching staff of 5 and auxiliary staff of 8.

We are a minority institution, permanently un-aided and to promote Moral Education we have Deeniyat/Moral Science Classes right from the Pre-primary to Std. X. We believe that moral development and academics go hand in hand. Our main aim is to understand the slow learners and uplift them to the level of the class by giving remedial support after school hours.

The teachers take initiative in guiding the students for scholarship exams held every year at different levels. We have trained and dedicated staff in all areas who cater to the all round development of the students

We have trained and dedicated staff in all areas who cater to the all round development of the students. For Primary and Secondary we follow the Maharashtra State Board Curriculum with CCE pattern (Continuous Comprehensive Evaluation) from Std I to Std VIII where observation of the student is done on a daily basis. The child is involved in various class room activities and is given a chance to express his ideas. The child's Academic Performance is measured in a series of Formative and Summative Examinations with a lot of emphasis on learning through doing process. In Std IX we follow the system of two Unit Tests and two Semesters and in Std. X we have 1 Unit Test 1 Semester, 2 Prelims and Regular test series with Study Camps.

'A' GRADE CERTIFICATE: Since last 3 years, the school is consistently getting 'A'-Grade Certificate from the Maharashtra Board of Secondary Schools, Pune. The school is consistently achieving 100% results of SSC. The 9th Batch of SSC students (appeared in March 2014) has made us proud by not only achieving cent percent result as in all these years but with the highest score being 93%. Our school received the Best School Trophy and Mr. Azeem Durrani received the Best Principal award from Mr. P.A. Inamdar Academy Pune, in P.A. Inamdar Computers Literacy Championship. The school conducts competitions like Drawing, Handwriting, Essay writing in different languages, Debate and Quiz competitions, Fancy Dress, Scout and Guide competitions, Elocutions, Story-telling, Poetry recitation, Extempo, etc. Certificates are awarded to the winners and participants to boost their talents and encourage them. The school conducts classes & competitions for Scout & Guide, Cooking & Repairs & maintenance of house hold appliances.

The Staff is given good opportunity to attend various workshops and seminars to understand and study the day to day changes and innovations happening in the field of education. To ensure that our students are equipped to face any challenge we have focused sessions on special topics including disaster management, leadership skills, fire prevention, social responsibility, first aid and health education, career planning and development etc.

PTA meetings are regularly conducted to review the activities of our school and seek the parent's participations and feedback about our activities.

MESCO Trust (the Parent Organization) renders its help to 103 deserving and 55 Very Deserving students of our school by providing them substantial scholarships on a continuing basis.

# **MESCO EDUCATION SOCIETY's Vocational Training Centres' Activities**

Vocational training is about "imparting of specialized skills and knowledge, instilling social and political attitudes and behaviour patterns for successful economic activities". Vocational training upgrades the skills, helps in capacity building, expands livelihood opportunities for the underprivileged, unreached informal sector workers and plays a key role in the national development.

Both vocational education and skill development have been known to increase productivity of individuals, profitability of employers and expansion of national development. A 'knowledgeable' workforce, one that is both highly skilled in a particular occupation, is seen as the most important human capital required for the development of a country.

MESCO Education Society and Fr. Agnel Technical College, Bandra are making an effort to develop a country with skilled people who can support economic growth of the nation. In last six years, we have realized that a technical skill can bring a tremendous mould in the life of an individual in general and society as a whole. In these years we have trained & skilled 360 students in 6 different trades namely, Electrician, Professional Beautician, Dress-Making & Fashion Designing, Computer Hardware & Networking, Information Technology and Refrigeration & Air Conditioning. There are 243 Students enrolled in all courses put together for the academic year 2013-14 (academic year is from September to August).

In our Dharavi Centre, we have trained 46 Students in Beautician Course and 52 Students in Sewing (Tailoring) course in the year 2013-14.

Our technical training is being assisted by Godrej & Boyce. The technical team from Godrej visits our centre regularly which provides the extra edge for our learners. Also students from Electrician, Beautician and A.C. & Refrigeration go for Industrial visit at Godrej Campus, Vikhroli which boosts the students self confidence for better performance.

By the Grace of Almighty, many students are employed in different Govt. & Private sectors and earning decent income supporting their families. Some of them are working in MSEDCL, Lodha Group, Lakme, Godrej, etc. Many of them are self employed. The average salary is Rs 5,000/- p.m. & the highest earning has crossed Rs. 40,000/- p.m.

The feedback collected from the students of different trades highlights the successful implementation of skill development plan. The promising results after the conduct of these non-formal vocational training courses are showcasing the MESVTC's contribution towards the employment generation and socio-economic development of the country.

# **MESCO EDUCATION SOCIETY'S Angels' Paradise Nursery Schools**

The first six years in a child's life are very crucial. It is in these years that the physical, language and the social development of the child is at the peak. Investment in Early Childhood Care and Education is therefore very essential. With this in mind, MESCO EDUCATION SOCIETY has started a Chain of English Medium Nursery Schools in slum localities of Mumbai Suburb. Children in the age group of  $2\frac{1}{2}$  to  $3\frac{1}{2}$  years of age are enrolled. They come from nearby localities. The children from the lower and middle lower income group and slum dwellers are the main target. You would be pleased to know that the Nursery School programme is one of our oldest institutional activity which was launched almost 41 years back with 1 Nursery school. As we look back we estimate that almost 10,000 students must have received their first schooling in one of our Nursery schools spread across Mumbai Suburbs.

During the Academic year 2013-14, MESCO Education Society (MES) managed 14 English Medium Nursery Schools with brand name of ANGELS' PARADISE NURSERY SCHOOLS in different disadvantaged areas in Central, Western and Northern Suburbs of Mumbai. Our efforts were to translate the modern concept of pre-primary education that of child centred/initiated learning in the physical classroom situation.

We have a learning by doing curriculum, with lot of group activity, language game, singing and experiential learning. We encourage our teachers to observe other schools curriculum and techniques. The new experience is shared with the other teachers once a month.

In the academic year 2013/14 we started 2 new schools i.e. at Sangam Nagar Antop-Hill and Baigan Wadi Govandi out of which initial cost for setup of Antop Hill nursery was sponsored by Jamanalal Bajaj Foundation. Inspite of lot of canvassing we had low enrolment.

In the academic year 2013/14 National Days, Children's Day, and Eid Milan programmes were celebrated in all the Nursery Schools.

Dental check up was conducted by Dr. Afshan Laheji in collaboration with Indian Dental Association (IDA) on Thursday 29th August, 2013 and 23rd November, 2013 at M.E.S. Angels' Paradise Nursery Schools at Kapadia Nagar, Kurla and at Govandi respectively for the students from 6 Nursery Schools.

Teachers Day was celebrated in all the Nursery Schools. Parents were called to help their child to prepare Teachers Day card from waste material.

In academic year 2013/14 seven workshops was conducted on different topics to upgrade the teachers' skills. Various field trips were organized for all our Nursery Students.

Fun-N- Fair and puppet show was organized on 25th December, 2013 and 25th January, 2014 at Angels' Paradise Nursery School Sewri & Govandi-I respectively.

Sports Day was held on 1st February, 2014 at Angels' Paradise Nursery School Kurla Kapadia Nagar. Students of Nursery School Kapadia Nagar, Quresh Nagar Kurla (E) and Bharat- Nagar, Bandra (E) participated.

Teaching Aids exhibition was held on 1st March, 2014 at Angels' Paradise Nursery School Dharavi. Mrs. Joyce Pinto Principal of St. Anthony High School Primary Section inaugurated the programme. It was attended by well known school Principals, Teachers and Parents.


