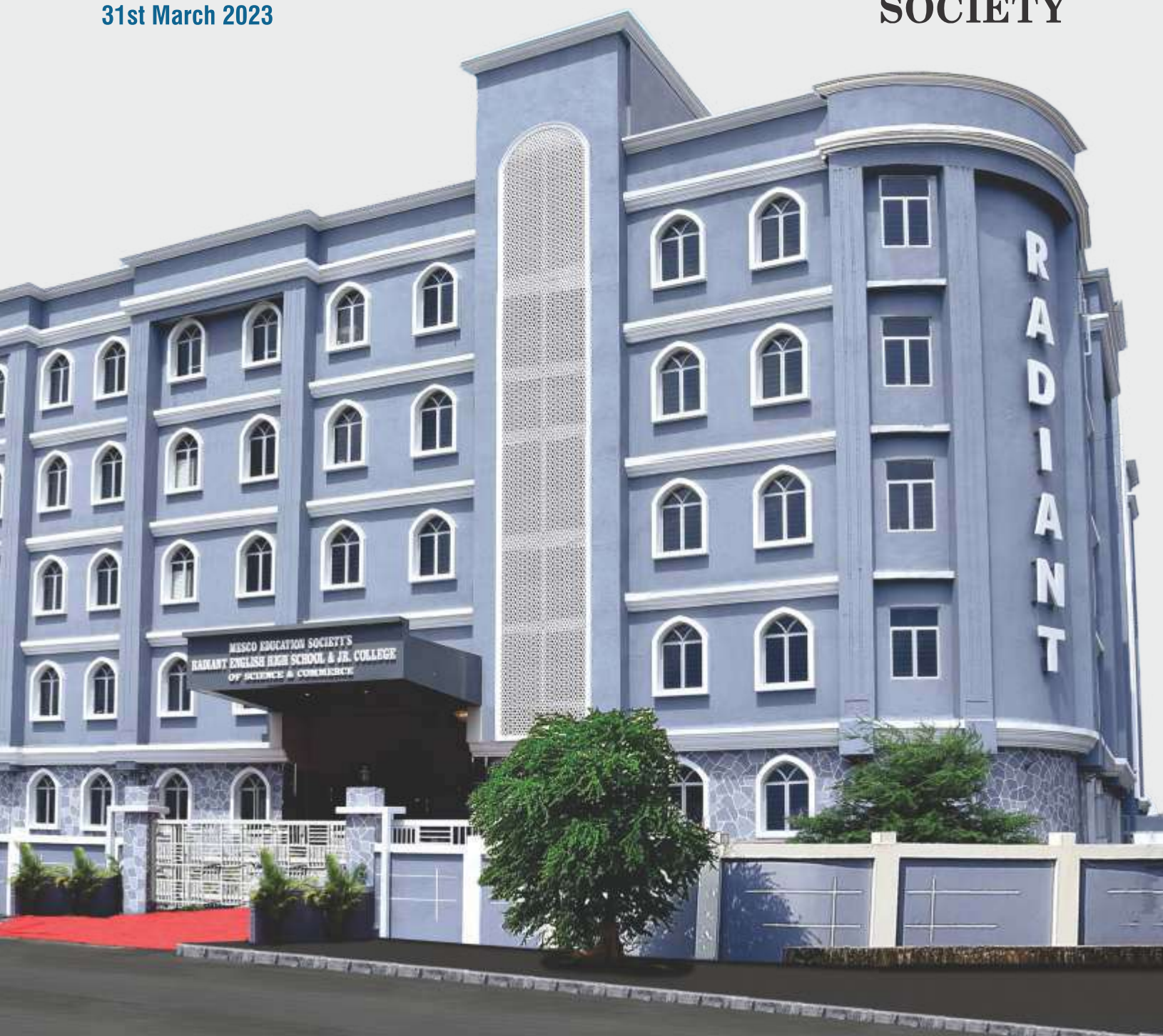

The Secretary's Annual Report 2022-23

Respected President, Managing Committee Members of MESCO Education Society (MES) and distinguished Patron Members, Life Members, Well-wishers and my staff, it is really a matter of pride to present the Secretary's Report of MESCO Education Society on the occasion of the 46th AGM.

We are thankful to you for your blessings, cooperation and support over the years.

During the year under report, we welcomed Mrs. Ainul Attar and Mr. Nazarul Islam Kazi as Managing Committee Members and Mr. Hafizuallah Baig as an Advisory Committee Member of MES.

On 6th August 2022, a Felicitation cum Send Off Function for Mr. Saeed Ahmed Vohra (one of the 7 Founding Members of both MESCO and MES) was organized at Crescent English High School. The gathering acknowledged his 54 years of dedicated service to the mission of the organizations. He was requested to join the Advisory Committee of MES, which he accepted.

MES participated in '100 Heroes' a Fund Raising Campaign (of Give India) during Daan Utsav from 2nd October to 20th November 2022 and was able to raise Rs. 5,83,777 and again in March 2023 MES participated in the 9th edition of Give Fundraising Challenge and was able to raise Rs. 8,95,042 for the sponsorship of Economically Weaker Section (EWS) Students.

25% of seats in both Crescent and Radiant School & Junior College are reserved for the EWS students.

On 3rd December 2022, MES got registration at Benevity Causes Portal (Benevity is a globally trusted fund raising platform).

Finances during the year : The Balance Sheet for the year under report shows that the Trust Funds / Capitalized amount stands at Rs. 40.15 Crores, while Investments are at Rs. 6.59 Crores. The Income & Expenditure Account shows an income of Rs. 13.10 crores and an Expenditure of Rs. 6 crores leaving a Surplus of Rs. 7.10 crores (which includes Rs. 6.53 crores received for school construction) and which would be utilized in the next financial year for the said purpose.

Corporate Social Responsibility (CSR) : Since 2021, MES is registered with Ministry of Corporate Affairs for undertaking CSR activities.

On 25th August 2022, MES got registration of National CSR Exchange Portal of Ministry of Corporate Affairs (MCA).

We are grateful to Corporate donors for contributing Rs. 25 lakhs

during 2022-23 for our projects.

I look back with a sense of pride at the amazing progress our Society and all its Educational Institutions have made during 2022-23.

New School Project : (Radiant English High School and Jr. College): The entire team of MES (my colleagues on the Board and our dedicated staff) worked relentlessly to establish another A+ Quality Educational Institution 'Radiant English High School and Jr. College' at Kausa, Mumbra, Dist. Thane. The establishment of the said school was only possible through tireless efforts, dedication and commitment of our team and our donors' confidence; all of which helped us reach where we are now. We look forward to their continued commitment in the journey forward. Radiant English High School and Jr. College will help us to educate another 3500 students (in full capacity). The newly constructed school building will be catering to about 1400 students with effect from June 2023.

We are fortunate that 341 donors contributed towards this project.

To acknowledge the significant support of major donors, in the newly constructed School building's main entrance lobby, MES put up a 'Legacy Wall', where MES has mentioned the names of all consenting major donors who donated Rs. 10 lakhs and above.

Following is a report on our Educational Institutions :

Crescent English High School and Jr. College : MES' Crescent English High School & Junior College continues its journey of excellence over last 30 years. Our School's atmosphere is conducive for the intellectual, physical and mental growth of our students. Our 18th batch of SSC (Std X) which appeared in March 2023, also got 100% results as in the last seventeen previous years. Of the 67 students that appeared, 4 students scored 90% & above, 35 students secured between 89% and 75%, 21 students secured between 74% and 60% and only 7 (the remaining students) secured a Second Class. The class average percentage was 75.17.

Our 6th batch of HSC (Std. XII) have also secured 100% results in all the three streams. The topper of the Science stream secured 85.83% while Commerce stream's highest was 93.50% and the topper in Arts stream scored 87.50%. In the year 2022-2023 we had 1610 students on roll of which 766 were girls and 844 were boys. We have a 100% trained staff at all levels.

Our school got selected for the 2 years Access English Micro Scholarship Programme organized by the US Consulate. 30 students of Std. VIII were selected after a screening test, the programme will end in February 2024.

Ms. Shaikh Hamida our Geography Teacher received the Best Teacher Award from the Maharashtra Rajya Shikshak Sena Thane.

At the Inter collegiate Jr. College Fest, our College won the Best College Award for maximum participation, won 1st prize in Poetry Writing & Recitation, 1st Prize in Creative Writing, 2nd

Prize in Poster Making, 2nd Prize in Mehndi Competition, 2nd and 3rd prize in Counter Strike (IT Game).

Rajya Puraskar (State Level Examination) in Scouts Guides was cleared by 3 students of Std. XII Science. They were awarded with certificates by the Governor of Maharashtra at Mantralaya. Mr. Ashrafuddin Ansari our student of Grade XI Commerce received Gold Medal and is selected for the State Level Competition at the Taekwondo Championship 2022-2023.

Our 2 teams of school participated in the Football Tournament organized by Krida Bharti. Our under 14 team at Group A won the 1st position and under 19 team at Group B won the 3rd position. Beside this our Football team won the 1st position at the Reformation Cup Football Tournament and received trophy and certificate.

Radiant English High School and Jr. College: From the academic year 2020-21 we started taking admissions for 2 divisions of Nursery class of Radiant and classes were conducted in Crescent English High School premises. During the academic year 2022-23, we took admissions for 4 divisions (in Nursery) of Radiant and thus had an enrolment of 399 students in the Pre-Primary Section. The number of applications were thrice the number of seats available.

We now have 1374 students at Radiant for the academic year 2023-24 (from Nursery to Std. IV). Govt. compliances, procurement of school furniture fixture, school uniform and banking and finances are in place.

Nursery Schools : MESCO Education Society's Angels' Paradise Nursery Schools is a programme that provides stimulating Early Childhood Education in slum pockets of Mumbai. This project was initiated in the year 1977.

During the year under report our 11 Nursery Schools catered to 232 students. Our Nursery Schools ensure physical, mental and emotional development in children and acquisition of positive habits. The curriculum is imparted through Play-Way-Method to make learning more interesting.

The targeted students come from economically and educationally disadvantaged families. It aims to prepare these children access admissions in good high schools of the respective areas.

We have been fortunate to have deficits in 9 of the 11 Nursery schools being sponsored by our committed donors.

We are grateful to all our sponsors and donors, who have made it possible for us to still continue our oldest educational institutional endeavour. Of the 232 students enrolled in 2022-23, 201 (86%) students secured admission in good high schools of the respective areas.

Early Childhood Care & Education (ECCEd) Training : Since 2018, MES has been conducting this One year course.

We are proud to share that during the period under report, MES got the affiliation of Maharashtra State Board of Vocational

Education for conducting One year Certificate Course in Pre-School Teachers' Training.

34 students enrolled for the course of ECCEd in 2022-2023. The course covers various aspects of ECCEd, including Child's Development, Curriculum Designing and Planning, Teaching Methods and Assessment and Integrated Teaching, ECCEd Supports Children's Social, Emotional, Physical and Cognitive Development which are essential for a solid foundation. All our past students have been placed in good schools of the area including our own 2 schools.

Vocational Training Centres at Dharavi and Mumbra : MES conducts two Vocational Training Centres, one in Dharavi and the other in Kausa, Mumbra in collaboration with Fr. Agnel Technical College, Bandra and this partnership will be completing 14 years in 2023.

Skill Development is being given a great impetus by the Govt. and while we continue with all these self funded courses, exams and certification is being done by Fr. Agnel Tech. College, a very reputed Technical Institution of Mumbai. We are also trying to register with the Govt. as well.

Our Mumbra Centre conducts 4 comprehensive courses, namely Electrician, Air-Conditioning and Refrigeration, Dress Making & Fashion Designing (all of 6 months). Information Technology Courses (3 months) are conducted under affiliation with Maharashtra Knowledge Corporation Ltd. (MKCL).

We are proud to share that MES VTC has been appointed as an Authorized Learning Centre by the Maharashtra Knowledge Corporation Limited (MKCL) to conduct various KLiC (Knowledge Lit Careers) Courses.

To review the performance and impact of our Mumbra Centre, on 28th January 2023, we have released our third edition of the Ex- Students' Directory of Vocational Training Centre. This directory contains a listing of 876 students who were trained from 2008 until 2022. The results are very encouraging.

The number of students who completed their courses during the year under report are as follows:

Mumbra Centre: Electrician – 27, Refrigeration and Air Conditioning – 53, Dress Making and Fashion Designing – 53, Information Technology -74.

Dharavi Centre : Tailoring Course -55.

The year 2022-23 was an eventful and satisfying year for MESCO Education Society. We have to thank the Almighty for all that we have been able to achieve through our Institutions.

I wish to also record my deep sense of gratitude to all our collaborators and affiliates. I would also like to thank our Auditors M/s. CNK and Associates LLP and our Bankers for their co-operation and support.

AUDITOR'S REPORT

AUDITORS REPORT RELATING TO ACCOUNTS AUDITED FOR THE YEAR ENDED 31ST MARCH 2023 OF MESCO EDUCATION SOCIETY TRUST UNDER SUB-SECTION 2 OF SECTION 33 AND SUB-SECTION 2 OF SECTION 34 OF THE BOMBAY PUBLIC TRUST ACT 1950.

We, the undersigned Auditors hereby report.

- I. a) That the accounts are maintained regular and in accordance with the provisions of The Act and the Rules.
- b) That receipts and disbursements are properly and correctly shown in the accounts.
- c) That the cash balance and vouchers in the custody of the Manager on the date of the audit were in agreement with the accounts.
- d) That all books, deeds, accounts, voucher and other documents or records required by us were produced before us.
- e) That the register of moveable properties is maintained.
- f) That the Secretary appeared before us and furnished the necessary information required by us.
- g) That no property or funds of the Trust were applied for any object or purpose other than the object or purpose of the Trust.
- h) That there was no amount outstanding for more than one year.
- i) That tenders were invited for repairs or construction during the year exceeding Rs. 5,000/-.
- j) That no money of the Trust has been invested contrary to the provisions of Section 35.
- k) That no alienation of the immovable property of the Trust contrary to the provisions of Section 36 has come to our notice.
- l) That there are no special matters on which comment is necessary.
- m) That no case of irregular, illegal, or improper expenditure or failure or admission of recovery moneys or other properties belonging to the Public Trust or of loss or waste of money of other properties thereof have come to our notice and that the question of whether such expenditure, failure or omission or loss or waste having been caused in consequence of breach of Trust or misapplication or any other misconduct on the part of the trustees or any other person while in the management of the Trust does not arise.
- n) That the Budget required has been filed in the form provided by rule 16(A).
- II. a) That the maximum and minimum number of Trustees is maintained having regard to the provisions of the instrument of the Trust.
- b) That the meetings are held regularly and as provided by the instrument of the Trust.
- c) That the minute book of the proceedings of the meetings is maintained.

Significant Accounting Policy

A. BASIS OF ACCOUNTING

1) The financial statements have been prepared in accordance with the historical cost convention in accordance with the generally accepted accounting principles in India and the applicable Accounting Standards issued by the Institute of Chartered Accountants of India.
