





The Secretary's Annual Report

Respected Members,

It is my privilege to present the 48th Annual Report of MESCO Education Society (MES) for the F.Y. 2024–2025. This report provides a comprehensive overview of the work carried out by MES and its institutions, highlighting key accomplishments over the past year, from 1st April 2024 to 31st March 2025.

I extend my sincere gratitude to my fellow Managing Committee members for their valuable contributions, time and commitment during Board meetings and various events across our institutions. I would also like to express my heartfelt appreciation to the dedicated employees of MES and its institutions. Their tireless efforts in advancing the mission and objectives of MES are both humbling and inspiring.

The progress we have made over the past year has been truly remarkable and we look forward with enthusiasm to the opportunities and challenges of the years ahead.

MESCO Education Society is registered under 12A, 80G of the Income Tax Act, Foreign Contribution Regulation Act (FCRA Act 1976 & 2010) and Corporate Social Responsibility(CSR) registration. The organization also ensured timely filing of Income Tax Returns and submission of various required documents across multiple government agencies.

During the reporting period, on 31st January 2025, Mr. Idris Bhoira, a member of the Managing Committee, tendered his resignation due to his relocation outside Maharashtra, which limited his ability to actively participate in the organization's activities. However, he was inducted into the Advisory Committee in recognition of his continued interest and valuable contributions over the last three decades. Dr. Afshan Laheji (a renowned Dental Surgeon and recently elected as Vice President of Indian Dental Association, Maharashtra State) was inducted as a Sub-Committee Member with effect from 1st July 2024.

On 2nd August 2024, MES received 'Recognition Award' in the category of Excellence in Employee Hygiene (Academia) at the Inhfra Corporate Excellence Awards. Mr. Javed Maqsood (Managing Committee Member) received the Adarsh Shikshak Mahapore Award 2024. Prof. M. Farhaan Makba (Treasurer) received the Minority Education Award of Excellence from All India Ulema Board.

MES also had the pleasure of welcoming Mr. Mohsin Shaikh, Executive Officer of MES, as a Life Member, and Mr. Mushtaque Shaikh, Assistant to the Executive Officer of MES, as a Patron Member. During the period under report, the Constitution of Advisory Committee of MES and Manual of Human Resource, Administration Policies and Procedure for Crescent English High School and Jr. College and Radiant English High School and Jr. College were drafted and finalized.

Finances during the year: A look at the Income Expenditure Account for the year ended 31st March 2025 reflects that the total income received was Rs. 17.90 crores, of which donations and grants amounted to Rs.6.48 crores and interest on bank, deposits, school fees and miscellaneous income amounted to Rs.11.28 crores. On the Expenses side, Rs.9.91 crores was spent on the Institutions (Objects) and the other expenses including Rent, Taxes, Audit Fees, etc. that amounts to Rs. 15 lakhs. Surplus at the end of the year stood at Rs. 4.08 crores, which is largely due to the specific donation received for Crescent Degree College Construction project, which is in progress and the funds would be utilized by the next financial year for the said purpose. The Balance Sheet reflects that the total Property & Assets stood at Rs. 47.53 crores.

Chain of Nursery Schools in Slum Areas: Launched in 1974, this impactful project has provided early education opportunities to over 15,500 children, with 80–85% of them successfully gaining admission into reputed English medium schools in their localities. A heartwarming testament to its success is that former students are now enrolling their own children in our nursery schools. During the year under the report, we operated a network of 11 English Medium Nursery Schools across the slum areas of Mumbai and its suburbs, serving 244 students.

The core aim of this initiative is to offer young children a strong foundation through holistic development in a safe, clean and nurturing environment, where they feel loved, valued and inspired.

This supportive beginning ensures that their first step into the world of education becomes a positive and memorable experience, while also preparing them for admission into quality English Medium schools.

Crescent Degree College: With growing demand for higher education and limited degree colleges in the Mumbra area, we propose to upgrade Crescent English High School & Jr. College into a Degree College. This will provide accessible & affordable higher education for local students, especially girls and the underprivileged.

Due to paucity of Degree colleges in Mumbra area and to meet the academic and infrastructural needs of a good degree college, we plan to construct three additional floors on the existing school building. This expansion will not only facilitate the introduction of undergraduate courses but also allow us to add two extra divisions per class at the school level.

This will help accommodate the rising number of students and ease the growing pressure on admissions. This development marks a significant step toward fulfilling our vision of offering quality education from nursery to graduation, under one roof and empowering our community through inclusive and continuous academic support.

Crescent English High School and Jr. College: During the reporting year, the academic excellence, holistic development

and vibrant co-curricular involvement were the highlights of our School. With 1641 students and 85 staff, we continue to provide quality education rooted in values and innovation. The year was marked by dynamic celebrations and educational initiatives including National Reading Day, Yoga Day, Youth Skills Day, Education Week, Constitution Day and other highlights include Mental Health Awareness Program. We are pleased to share that this year, through our Vocational Training Centre, we have introduced the MS-CIT course for all our Std. VIII students. This initiative enables students to complete the course and appear for the governmentrecognized examination within a year, earning an official MS-CIT certificate. This certification not only enhances their digital literacy at an early age but also serves as a valuable credential for future opportunities, particularly when applying for government jobs.

We are delighted to announce that our school has secured 1st Position in the Mukhyamantri Majhi Shala Sundar Shala Abhiyan, organized by the Government of Maharashtra. As a mark of this achievement, we have been awarded a prize of Rs. 3 lakhs. Our school was selected at both the Taluka and District levels, standing out among 408 schools in Upazilla Resource Centre (URC)—1.

Our 20th SSC batch (2025) also got 100% results as in the past nineteen years .Of the 82 students who appeared, 48 students secured distinction (out of this 10 students scored above 90%), 28 students secured first class and 6 students secured second class. The class average percentage of this year was 76.60%, and the highest score was 96.00%. Our 8th batch of HSC (Std. XII) has also secured 100 % results in all the three streams. The class average for this year was 65.94% in the Science stream, 78.45% in the Commerce stream, and 67.39% in the Arts stream. The topper of the Science stream secured 84.67% while in Commerce stream highest was 94.33% and the topper in Arts stream scored 90.67%.

Radiant English High School & Junior College: The academic year 2024–2025 marked a significant milestone in the journey of Radiant English High School & Junior College. With a total student strength of 1,758, spanning from Nursery to Std. V and Std. XI (Commerce and Science), the year began on a promising note with the successful launch of our Junior College section.

Throughout the year, the school remained steadfast in its commitment to nurturing values, promoting talent, and ensuring holistic development through a diverse range of academic, co-curricular and awareness-driven activities. Among the key highlights of the year were the Annual Day, Yoga Day and Sports Day celebrations. These events witnessed the enthusiastic participation of all students with holistic participation which were a testament to the creativity and teamwork exhibited by both students and staff.

Radiant English High School made a remarkable impression in various interschool and national-level competitions. In the MFA School League 2.0 (Football Tournament), our Under-11 team emerged as winners, while the Under-9 team secured the runner-up position.

A proud moment for the school came when Ms. Memon Barirah Imtiyaz, a student of the Junior College, was selected for an exclusive Artificial Intelligence and Machine Learning (AI-ML) Workshop organized by American Spaces in collaboration with WSAI, IIT Madras.

One of the most memorable events of the academic year was the successful organization of our first-ever interschool competition, "Rising Stars Fest," held on 8th February 2025. This pioneering initiative witnessed the participation of 133 students from 17 different schools. The fest was conducted for 6 segments of competitions. All competitions were judged by independent evaluators to ensure transparency and fairness.

Vocational Training Centre at Mumbra and Dharavi : We express heartfelt gratitude to Fr. Agnel Technical College for their unwavering support and invaluable guidance over the past 17 years in helping us implement vocational courses at our Mumbra and Dharavi centers. At the Mumbra centre, we offer six-month courses in Electrical Assistant, Air Conditioning and Refrigeration Mechanic and Basic Fashion Designing, all these courses are affiliated with Maharashtra State Board of Skill, Vocational Education & Training (MSBSVET). We also offer three-month Information Technology courses affiliated with the Maharashtra Knowledge Corporation Limited (MKCL). The Dharavi centre focuses on empowering girls through a specialized Tailoring course aimed at building their skills and promoting self-reliance. These programs are carefully designed to equip students with practical, industry-relevant skills that enhance their employability and career readiness.

MES Vocational Training Centre was awarded a Certificate of Appreciation by the Maharashtra Knowledge Corporation Limited (MKCL) for initiating the MS-CIT course for students of Crescent School.

From 2008 to date, we have successfully completed 21 batches in the Electrician course, 17 in Air Conditioning and Refrigeration and 19 in Dress Making and Fashion Designing.

During the reporting year, 101 students completed the Electrician course, 100 in Air Conditioning and Refrigeration, 81 in Dress Making and Fashion Designing and 197 in Information Technology at the Mumbra centre. Meanwhile, 53 girls completed the Tailoring course at the Dharavi centre.

Pre-School Teachers' Training Institute: This course was started in the year 2017, a significant milestone was achieved in 2022-2023, when MES received official affiliation from the Maharashtra State Board of Vocational Education.

This course is designed to provide holistic training through a blend of theory sessions, practicals, guest lectures, educational field trips, NGO visits and more, ensuring the comprehensive development of aspiring educators.

This is a 100% job-oriented program, aimed at preparing professionals who are ready to contribute meaningfully in the field of early childhood education.

MES Study Centre: With the intention of providing a peaceful and supportive learning space for students who lack space at

home to study, MES established a Study Centre on 8th September 2024. As of 31st March 2025, a total of 243 students had benefited from this centre. The Centre is located within the campus of Radiant English High School & Jr. College.

The Centre offers a quiet, well-maintained, and fully equipped environment designed to foster focused learning and personal growth.

Operating from Monday to Saturday, 8:00 a.m. to 7:00 p.m. The Centre supports a wide range of learners from those preparing for College exams to students enrolled in Post Graduate-level courses, as well as aspirants preparing for competitive exams such as NEET, JEE, UPSC, CA, and UGC NET as well as departmental exams for promotion in their own companies.

In conclusion, this year has been a testament to our unwavering commitment toward Education and its impact on the lives of students. Despite challenges, our collective efforts have brought meaningful change to the lives we touch. I extend heartfelt thanks to our committed donors, dedicated team and collaborators for their continued trust and collaboration. Let us move forward with renewed energy and purpose.


